

SCHOLARSHIP DISBURSEMENT INFORMATION

Please disburse the full term or semester amount sent to your school. All funds should be disbursed to the student for the intended term provided the student meets the eligibility requirements listed on the front.

OSAC divides annual awards greater than \$1,000 into equal disbursements **before** sending funds to your school in an effort to maintain accurate remaining eligibility records. Some scholarships require "one-lump" disbursements even if the annual award amount is larger than \$1,000 and must be issued during the intended term or semester. The roster will indicate which amount is being sent and how much is to be disbursed.

- **Please do not divide, hold back, or return funds for a student who meets all eligibility requirements for the term in which scholarship funds have been sent.**
- **Funds left over after crediting a student account should be disbursed to the student in the usual manner to pay other education expenses, such as transportation and living expenses.**
