SB 3 Requirements & Course Scope



- **0.5 credit** in Higher Education & Career Path Skills (aka: CCR course)
- 0.5 credit in Personal Financial Education
- Applies to the Class of 2027 onwards
- Courses must be standalone; integration into other classes is not allowed

Higher Education & Career Skills include:

- Applying for jobs, college & apprenticeships
- Developing career-related skills and exploring experiential learning
- Seeking assistance and self-advocacy

Personal Financial Education includes:

- Credit scores, investments & debt
- Budgeting & insurance
- Taxes & consumer protection

HECPS (CCR) Standards & Instructional Guidance

Purpose of HECPS Instructional Guidance

- Help educators bring standards to life
- Connect learning to real-world experiences & cultural identities
- Foster self-awareness, curiosity, confidence & agency

TSEL Integration

- Support well-being & resilience
- Encourage empathy, cultural responsiveness & relationship skills

Socio-economic Considerations

- Acknowledge access disparities (such as resources, networks, etc.)
- Discuss systemic barriers & strategies for navigation

Culturally Responsive & Strengths-Based

- Honor cultural values, languages & community norms
- Validate lived experiences & build on student strengths

Rules & Roles



Licensed teachers

Licensed educators under atypical assignments and subject endorsements



Administrators

Administrators with valid teaching licenses may teach these courses



CTE & Counselors

Restricted CTE teachers and school counselors may also teach



Team Approach

- Avoid diverting counselors from essential counseling responsibilities
- Co-teach or share responsibilities so that students receive both course instruction, counseling services and advising support
- Consider co-teaching models, rotating instructors or partnering with other licensed staff and field experts

Collaborative Strategies



- Co-plan and co-teach standalone courses,
 integrating career exploration and financial literacy
- Embed career readiness skills into existing lessons through projects & guest speakers
- Offer targeted workshops on college admission, financial aid, scholarship searches & apprenticeships
- Build partnerships with local colleges, industry & community organizations for experiential learning
- Provide professional development to teachers on SB 3 standards & CCR topics

Identifying Strengths & Barriers
